PROVIDED AN UPDATE TO THE LOCAL HOUSING TRUST FUND (LHTF) PROGRAM WHICH IS ADMINISTERED THROUGH THE CALIFORNIA DEPARTMENT OF HOUSING AND COMMUNITY DEVELOPMENT; THE LOCAL HOUSING TRUST FUND HAS \$57,000,000 AVAILABLE TO ANY QUALIFYING TRUST ORGANIZATION; AN APPLICATION WAS SUBMITTED TO THE LOCAL HOUSING TRUST FUND AND OUT OF 31 APPLICATIONS, THE ORANGE COUNTY HOUSING FINANCE TRUST SCORED 2ND OVERALL



PROVIDED AN ADMINISTRATIVE FUNDING UPDATE; ADMINISTRATIVE BUDGET APPROVED BY THE TRUST IS \$450,000 AND THE TRUST HAS RECEIVED \$390,000 TO DATE; WILL BE FOLLOWING UP WITH CITIES REGARDING THEIR MEMBERSHIP
