# INTRODUCTION

As we detail in the pages that follow, this proposal highlights Politico Group's diverse team of advocates to address the varied needs of the Orange County Housing Finance Trust (Trust). The key personnel that would be assigned to the Trust bring extensive policy knowledge in the areas of housing, land use, and construction; we offer access to high-level policy makers in the Legislature, Newsom Administration, and the various agencies, departments critical to the Trust; and will bring energy, enthusiasm, and well-developed strategic and technical expertise that will successfully deliver results on behalf of the Trust.

# APPROACH AND SCOPE OF SERVICE

In this section, we describe our approach to achieving and delivering state advocacy services requested by the Trust. Key to any successful legislative and regulatory program are the following elements: increased profile, clear and regular communication, articulating and understanding objectives and expectations, and adjusting strategies to address and accommodate identified challenges.

As discussed in our transmittal letter, the Trust is taking a proactive leadership role in addressing what is arguably California's most pressing policy issue. California's housing crisis continues to plague individuals and families across the state. According to the California Housing Partnership, more than 1.4 million California households need affordable housing. In 2019, the California Department of Housing and Community Development cited a need for more than 1.3 million housing units to be built within the next decade. Nearly one-third of all Californians are spending more than fifty percent of their income on housing costs. Our lack of affordable housing has also played a key role in our homelessness crisis. While California only has 12 percent of the nation's total population, we have about 25 percent of the total homeless population in the country or approximately 150,000 people currently experiencing homelessness.

Given this sobering reality, the Legislature and Newsom Administration continue to focus on the availability and affordability of housing as top priorities in both the legislative and budget realm. On the budget side, record levels of investment from the state budget surplus, federal COVID-19 relief funds, the 2018 Proposition 1 housing bond, and SB 2 (Ch. 364, Stats. 2017) are likely to be accompanied by additional investment in upcoming years through a projected state budget surplus next year, potential federal funding for affordable housing allocated to states, and a legislative vehicle sponsored by the Senate President pro Tempore that would put an additional affordable housing bond on the statewide ballot. On the legislative front, the Legislature has continued to pass bills to change local processes surrounding housing approvals, increase accountability and authority via the California Department of Housing and Community Development (HCD), impose conditions on the disposition of surplus local government property, and reform the Regional Housing Needs Allocation process. On the latter topic, the Administration is currently working a report by the HCD, which is due back to the Legislature in 2023.

To influence both the legislative and administrative/budgetary items discussed above on behalf of the Trust, Politico Group will take the following technical approach toward raising the Trust's profile, actively lobbying on legislative and budget items of interest, and engaging in regulatory and administrative processes, such as the development of funding guidelines:

**Increased Profile:** To further the goals and objectives of the Trust, Politico Group will establish and maintain relationships and channels of communication with elected state officials, appointees, and other key policy makers. To achieve this Politico Group will:

- 1) Conduct meetings, on behalf of Orange County Housing Finance Trust with pertinent legislative committee chairs, staff, and members. These will include, but not be limited to, the Chair and members of the:
  - a) Assembly:
    - i) Housing and Community Development Committee
    - ii) Local Government Committee

- iii) Appropriations Committee
- iv) Budget Subcommittee No. 4 on State Administration
- b) Senate
  - i) Housing Committee
  - ii) Governance and Finance Committee
  - iii) Appropriations Committee
  - iv) Budget and Fiscal Review Subcommittee No. 4 on State Administration and General Government
- 2) Schedule, create agendas for, and conduct meetings with, key state and agency officials of the:
  - a) California Business, Consumer Services and Housing Agency
  - b) California Department of Housing and Community Development
  - c) Governor's Office of Planning and Research
  - d) California Housing Finance Agency

**Lobbying:** Politico Group will provide high level and effective state lobbying at the legislative, administrative and regulatory levels. These services will include:

- 1) Legislative
  - a) If the Trust adopts positions on pending legislation during session, Politico Group will:
    - i) Research and provide analysis on legislative and budget issues, including providing strategic council for the development of recommended positions;
    - ii) Prioritize and recommend action for legislation;
    - Develop and submit position letters to the policy committees, fiscal committees, the floors of each house, and the Governor's office on priority issues where the Trust has adopted a position of Support, Support If Amended, Opposed or Opposed Unless Amended;
    - iv) Meet with the authors, sponsors, committees, staff and members of the Legislature to communicate support or opposition on legislation and/or propose amendments;
    - v) Develop background papers and materials to assist in communicating the Trust positions to legislators;
    - vi) Provide representation and testimony in committees on priority issue; and
    - vii) Work to recruit additional support or opposition as needed.
  - b) If the Trust determines that it needs to sponsor legislation, Politico Group will:
    - Identify and secure an author to introduce legislation on behalf of the Trust, including securing coauthors who are aligned with the objectives of the Trust and provide the best opportunity for success of the issue;
    - ii) Work with Legislative Council to ensure bill text, and any subsequent amendments, are properly interpreted and drafted into the bill;
    - iii) Work with the author's staff to assist in the development of testimony, position papers, and floor statements that are consistent with the Trusts' position;
    - iv) Communicate with the consultants and staff of the committees in which the bill will be considered to ensure that the analysis is balanced and properly describes the issue to the committee;

- Meet with members of the committees and members in each house to advocate the Trust's position on the bill. This also includes leadership in the Assembly and Senate and the Governor's office;
- vi) Provide testimony and coordinate expert witnesses during legislative hearings;
- vii) Determine and attempt to neutralize opposition to the bill, including drafting, proposing and managing amendments to address concerns; and
- viii) Facilitate the support of associations and industry groups with similar interest and coordinate lobbying efforts.

# 2) Bill monitoring:

On a daily basis, Politico Group will monitor all introduced bills and amendments utilizing Capitol Track bill tracking service. All bills will be read and analyzed and we will establish a tracking list specific to the Trust. In consultation with the Trust, the following positions will be assigned:

- Watch
- Pending
- Support
- Support If Amended
- Oppose
- Oppose Unless Amended

Throughout the session, Politico Group will routinely monitor legislation to identify bills that might affect the operations and objectives of the Trust. In conjunction with the Trust, we will then develop effective arguments or amendments to the legislation that will promote the best interests of the Trust.

# 3) Regulatory and Administrative

Although not as glamorous as the legislative process, the actions taken in the regulatory and administrative arena are often the most time consuming and arduous. The state entities overseeing housing planning and funding within the State of California has continued to grow as the Legislature provides HCD with new powers and responsibilities. Moreover, recent state budget investments, legislation, and the 2018 housing bond have resulted in unprecedented amounts of funding for various housing production and planning activities.

Politico Group will monitor, analyze, and influence agencies with administrative actions of interest to the Trust. The process for regulations and funding guidelines will be handled similar to legislative matters. Politico Group will work with the the Trust for to establish platform language and policy direction. Once established, Politico Group will take whatever steps are necessary to best represent the Trust. The following is list of regulatory agencies whose actions frequently include housing funding issues:

- a) California Business, Consumer Services, and Housing Agency Homeless Coordinating and Financing Council
- b) California Department of Housing and Community Development
- c) California Housing Finance Agency
- d) California Debt Limit Allocation Committee
- e) California Tax Credit Allocation Committee

In addition to the agencies listed above, Politico Group will maintain an active oversight of all the agencies, boards, commission, and offices that impact the business of the Trust.

# **Communication:**


# **STAFF DESCRIPTION AND EXPERIENCE REPRESENTING PUBLIC AGENCIES**

This additional staff member has eight years of experience advocating on local government housing planning and funding policy at the California State Legislature, as well as over five years of local government experience, focusing on intergovernmental relations with cities, regional agencies, and joint powers agencies, as well as pursuing local government legislative and budget priorities at the state and federal level.

# Kiana Valentine – Partner, Politico Group

Ms. Valentine has more than 15 years of policy experience in local government issues, including housing, land use, transportation, and infrastructure.
