ON THE MOTION OF CHAIR FOLEY, SECONDED BY DIRECTOR KIM, BY A VOTE OF 8 TO 0, THE BOARD UNANIMOUSLY APPROVED ITEM AS AMENDED TO APPROVE A REVISED AMENDMENT AMOUNT TO ADD \$40,000 TO THE CURRENT CONTRACT YEAR ENDING DECEMBER 31, 2023 AND TO WORK TO FORM AN AD HOC COMMITTEE TO REVIEW CIVICHOME CONSULTING CONTRACT, DISCUSS FY 2024/2025 BUDGET, AND 2024 TRUST STRATEGIC PLAN RETREAT AGENDA AND RETURN TO THE BOARD WITH RECOMMENDATIONS BY THE SECOND MEETING OF THE YEAR.
