Subject: OCHFT Lobbying Update

We look forward to joining your Board of Directors meeting to provide more insight into legislative activity in Sacramento. With the end of the legislative session on August 31, 2020, there is much to report including all the behind-the-scenes work in our attempt to secure funding for the Trust.

When we started our engagement with the Trust, our legislative strategy and objectives were defined by a clear path to securing \$35 million of General Fund dollars to augment projects that provided affordable and supportive housing in Orange County. Our lobby team in conjunction with Trust Staff and the County met with most the Orange County Legislative Delegation in Sacramento and we were all very optimistic.

Then the COVID-19 pandemic hit and changed the landscape.

In January, Governor Gavin Newsom released an ambitious plan to combat homelessness and affordable housing. Many of the Governor's initiatives complimented the Trust plans and we identified a legislative strategy that would harness the support of the entire Orange County legislative delegation to make the funding request. While COVID quickly changed the state's financial landscape, Orange County legislators remained committed to requesting dollars for shovel ready projects identified by the Trust. Again, our lobby team, Trust Staff and the County held many virtual calls with the Governor's office, leading and influential legislators in the State, and the Orange County Legislative Delegation.

Led by Assemblywoman Cottie Petrie-Norris, the Orange County Legislative Delegation submitted a request for a state budget augmentation for the Trust during the closing days of the 2020 legislative session. This request included multiple members of the delegation and was one of the very few legislative member requests for additional district funding.

Unfortunately, given the state's unknown financial future the budget committees in both houses of the Legislature did NOT consider any specific member requests. While this outcome is disappointing, we cannot overlook the progress we made educating Sacramento on Trust priorities and the regional collaborative approach Orange County has set to solve our affordable and permanent supportive housing crisis. This outreach will serve as the foundation of the Trust's next efforts to secure additional funding from the state – which should start this fall to influence the Governor's January Budget Proposal. We will speak further to this recommendation during your board meeting.
