### REQUEST FOR ORANGE COUNTY HOUSING FINANCE TRUST (OCHFT) BOARD ACTION

**MEETING DATE:** December 19, 2019

**SUBJECT:** Approval to submit draft legislative bill and selection process for lobbying firm.

#### **RECOMMENDED ACTION:**

- 1. APPROVE THE PROPOSED BILL LANGUAGE, INCLUDED AS ATTACHMENT A,
  APPROPRIATING FUNDING IN THE AMOUNT AS DIRECTED BY THIS BOARD FROM THE
  STATE OF CALIFORNIA GENERAL FUND TO THE OCHFT AND AUTHORIZE STAFF TO
  IMPLEMENT THE FUNDING STRATEGY AD HOC COMMITTEE RECOMMENDATION TO
  WORK WITH LOCAL LEGISLATORS TO FINALIZE THE BILL.
- 2. AUTHORIZE STAFF TO MAKE EDITS TO FUNDING AMOUNT BASED UPON LEGISLATIVE AND LOBBYIST RECOMMENDATIONS WITHOUT FURTHER BOARD ACTION.
- 3. PROVIDE DIRECTION TO STAFF FOR PROCURING LEGISLATIVE ADVOCACY SERVICES; AND DIRECT STAFF TO RETURN TO THE BOARD IN JANUARY 2020 WITH A RECOMMENDATION FOR PROVISION OF SAID SERVICES.

#### **BACKGROUND:**

At the October 2019 OCHFT Board Meeting, the Board approved the formation of the Funding Strategy Ad Hoc Committee ("Committee"), consisting of Chair Jennings, Vice-Chair Do, and Board Member Chaffee. Staff met with the Committee on December 3, 2019 and discussed several issues relevant to funding the OCHFT.

Significant among the topics discussed included a proposed legislative bill that would appropriate funding to the OCHFT to finance the development of affordable and permanent supportive housing for those experiencing homelessness in Orange County.

Staff has prepared language for a draft legislative bill that would begin the dialogue with local legislators. If approved, Staff will coordinate with the Funding Strategy Ad Hoc Committee members to meet with local legislators and seek their support and feedback.

For this bill to be introduced in the 2020 legislative calendar, there are required legislative meetings and committee deadlines in January 2020. The Funding Strategy Ad Hoc Committee directed Staff to schedule this special meeting of the Trust to receive direction from the Board in order that we meet these upcoming deadlines.

To navigate the legislative bill process, the Trust will need a legislative advocacy services firm. Staff requests Board direction on the selection process for the procurement of the firm. One alternative would be to direct staff to solicit recommendations on advocacy services and return to the Board with a list of qualified firms for selection and commencement of negotiations with the selected firm.

The chosen lobbyist will be integral in helping finalize the bill and improving the chance that funding will be approved for the purpose intended. It is important that this legislative bill introduces to Sacramento the homelessness crisis facing Orange County. In addition, the delegation promoting this bill will emphasize the Trust regional effort of local government and highlight the private stakeholders experience and capacity. This Trust driven collaborative approach to a regional housing crisis is exactly what the State can support as a model for other areas. To that end, Staff also requests Board direction on the source of payment for the Trust's advocacy services.

The mission of the Trust is to strengthen the communities in Orange County by financing the development of housing for the homeless and low-income individuals and families. The key to achieving that mission is to aggressively seek out and obtain funding.

Staff and the Funding Strategy Ad Hoc Committee recommends approval of this agenda item.

# DRAFT - ORANGE COUNTY HOUSING FINANCE TRUST GAP FUNDING BILL

Existing law, AB 448 (2018), authorized the creation of the Orange County Housing Finance Trust (Trust) for the purposes of funding housing specifically assisting the homeless population and persons and families of extremely low, very low, and low income within the County of Orange.
This bill would appropriate \$ from the State General Fund to the State Department of Housing and Community Development for distribution to the Trust. Appropriated funding would be distributed on January 1, 2021 and would require the moneys to be used to provide funding to develop affordable and permanent supportive housing for those experiencing homelessness throughout Orange County. The funding would specifically assist persons and families of extremely low, very low, and low income, as defined in Section 50093 of the Health and Safety Code.
THE PEOPLE OF THE STATE OF CALIFORNIA DO ENACT AS FOLLOWS:
SECTION 1. The legislature finds and declares all the following:
<ul> <li>(a) The County of Orange is in the midst of a homelessness crisis.</li> <li>(b) On September 11, 2018, AB 448 (2018) was signed into law establishing and authorizing the Trust to respond to the homelessness crisis.</li> <li>(c) To date, the County and twenty-one cities within the County of Orange have collaboratively formed the Trust and worked with developers and service providers to create a pipeline of affordable and permanent supportive housing projects needing gap funding to address the crisis throughout Orange</li> </ul>
County.  (d) The Trust pledges \$ of their own funds towards capital improvement projects and all other necessary administrative funding for the Trust.
(e) The sum of is hereby appropriated from the State General Fund to the State Department of Housing and Community Development for distribution to the Orange County Housing Finance Trust to fund the development of affordable and permanent supportive housing for those experiencing homelessness throughout Orange County. The funding would specifically assist persons

and families of extremely low, very low, and low income, as defined in Section 50093 of the Health

and Safety Code.
