Approve Orange County Housing Finance Trust minutes from the September 15, 2021, meeting ON THE MOTION OF CHAIRMAN CHAFFEE, SECONDED BY DIRECTOR BARTLETT, BY A VOTE OF 7 TO 0, WITH DIRECTORS BARNES AND FREIDENRICH BEING ABSENT, APPROVED THE ORANGE COUNTY HOUSING FINANCE TRUST MINUTES FROM THE SEPTEMBER 15, 2021 MEETING

  - ON THE MOTION OF DIRECTOR BARTLETT, SECONDED BY DIRECTOR SACHS, BY A VOTE OF 7 TO O, WITH DIRECTORS BARNES AND FREIDENRICH BEING ABSENT, APPROVED TOWNSEND PUBLIC AFFAIRS TO REPRESENT THE ORANGE COUNTY HOUSING FINANCE TRUST FOR STATE LEGISLATIVE ADVOCACY AND LOBBYING SERVICES THROUGH SEPTEMBER 15, 2024; AND AUTHORIZED THE TRUST MANAGER TO EXECUTE AGREEMENT
- 3. Approve operating agreement between the Orange County Housing Finance Trust (Trust) and Orange County Community Foundation (OCCF) to establish a donor advised fund; authorize the Trust Manager to execute the operating agreement and setup form; and authorize trust manager to establish a link on the trust website for direct donations to the established OCCF donor advised fund to benefit the trust.
  - ON THE MOTION OF VICE CHAIRMAN FAESSEL, SECONDED BY DIRECTOR PENALOZA, BY A VOTE OF 7 TO O, WITH DIRECTORS BARNES AND FREIDENRICH BEING ABSENT, APPROVED ITEM AS RECOMMENDED
- 4. Option to resume in person meetings or continue to meet virtually pursuant to newly enacted legislation and, if virtually, amend regular calendar to meet monthly ON THE MOTION OF CHAIRMAN CHAFFEE, SECONDED BY DIRECTOR FEDERICO, BY A VOTE OF 5 TO 1, WITH VICE CHAIRMAN FAESSEL VOTING NO AND DIRECTORS BARNES, BARTLETT AND FREIDENRICH BEING ABSENT, VOTED TO RESUME IN PERSON MEETINGS EVERY OTHER MONTH IN 2022
